**Must be installed per installation manual. Deviations will prorate warranty.

All items must be returned for evaluation to Solar Lighting International for consideration of warranty repair/ replacement. The Warranty Period commences at the time of invoicing. Items must be returned in the same condition as received.

Limited Replacement Warranty: If after discussing a problem with SLI's tech department and it is determined, by SLI, that the X-LED or Stealth model does not function properly during the applicable warranty period, SLI will provide the Customer with an RMA# to return the defective units for evaluation. If SLI determines the unit is defective, a replacement part/ or fixture will be replaced at no charge (less freight). It is the sole discretion of SLI to determine if a component or part is not functioning properly and that replacement is necessary. SLI's limited replacement warranty does not extend to freight or the cost of installation, which is the responsibility of Customer.

Warranty does not cover shipping damage, acts of God such as flood, lightning strikes, acts of war and / or system neglect by incorrect installation, incorrect storage of systems, their parts or lack of scheduled panel cleaning / maintenance. High Wind Areas may require pole wind certificates if poles are not supplied by Solar Lighting International.

Exclusions: This limited replacement warranty is void by improper installation by the installer or improper handling by the carrier during the course of transport. This limited replacement warranty does not cover defects caused by natural forces beyond SLI's control, such as weather conditions, acts of God, or system neglect.

SLI AND CUSTOMER AGREE THAT ALL DISPUTES ARISING OUT OF OR RELATING TO THIS INSTALLATION GUIDE IN ANY WAY, WHETHER BY VIRTUE OF CONTRACT, TORT, OR OTHERWISE, SHALL BE SETTLED EXCLUSIVELY BY ARBITRATION IN ACCORDANCE WITH THE S.C. UNIFORM ARBITRATION ACT AND THE FEDERAL ARBITRATION ACT.
